## NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966 (80 Stat. 271; 1 U.S.C. 113)—

"...the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence ... of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof." 670/99

The Embassy of the United States of America presents its compliments toethe Ministry of Foreign Affairs of Ukraine and has the honor to acknowledge receipt of Note No. 4-3/37-428/13 dated April 23, 1999 from the Ministry of Foreign Affairs of Ukraine which proposed that the Agreement between Ukraine and the United States of America concerning Assistance to Ukraine in the Elimination of Strategic Nuclear Arms and the Prevention of Proliferation of Weapons of Mass Destruction signed on October 25, 1993 be extended to December 31, 2007.

The Embassy of the United States of America proposes instead that the Agreement be extended for an additional six years, until December 31, 2006. If this proposal is acceptable to the Government of Ukraine, the Embassy further proposes that this note together with the Ministry's reply to that effect shall constitute an agreement between the two governments which shall enter into force on the date of the Ministry's note.

The Embassy of the United States of America avails itself of this opportunity to renew to the Ministry of Poreign Affairs the assurances of its highest consideration.

The Ministry of Foreign Affairs of Ukraine would like to take this opportunity to renew to the Department of State of the United States of America the assurances of its highest consideration.
