NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966
(80 Stat. 271; 1 U.S.C. 113)—

“ . . .the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence . . . of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof.”

The Embassy has the further honor to propose to the Government of the Republic of Trinidad and Tobago that the Government of the United States of America and the Government of the Republic of Trinidad and Tobago agree to further extend the 2013 SOFA, without any other changes, for an additional two (2) months from its expiration date of July 1, 2022, to September 1, 2022.

If the foregoing proposal is acceptable to the Government of the Republic of Trinidad and Tobago, the Embassy proposes that this note, together with the Ministry's reply to that effect, shall constitute an Agreement between the two Governments that shall enter into force upon the date of the Ministry's reply.

The Ministry of Foreign and CARICOM Affairs of the Republic of Trinidad and Tobago is pleased to confirm that the proposal set forth in the Embassy's note is acceptable to the Government of the Republic of Trinidad and Tobago and that the Embassy's note together with this note in reply shall constitute an agreement between the two Governments which shall enter into force on the date of this note.

The Ministry of Foreign and CARICOM Affairs of the Republic of Trinidad and Tobago avails itself of this opportunity to renew to the Embassy of the United States of America the assurances of its highest consideration.
