NOTE BY THE DEPARTMENT OF STATE

THE GOVERNMENT OF THE UNITED STATES OF AMERICA AND THE GOVERNMENT OF THE KINGDOM OF DENMARK, hereinafter the Contracting Parties,

NOTING THAT the Government of the United States of America has given notice of its intent to terminate the Agreement between the United States of America and the Kingdom of Denmark relating to the establishment of the Long-Range Radio Aid to Navigation (Loran-C) station at Ejde, Faroe Islands, effective December 31, 1994, and

REAFFIRMING their commitment to maintaining a reliable system of navigation to enhance the safety of navigation worldwide,

HAVE AGREED as follows:

#### **Article I**

The Government of the United States of America shall transfer operational control of the Loran-C transmitting station at Ejde, Faroe Islands, to the Government of the Kingdom of Denmark effective at midnight December 31, 1994. The Government of the United States of America shall relinquish to the Government of the Kingdom of Denmark any and all rights to use, control, maintain, and operate the aforementioned station on that date. The Government of the Kingdom of Denmark shall take possession and title on that date of the real property, building and fixtures at the station. The Government of the Kingdom of Denmark shall take possession and title on that date of all U.S. owned fixed-station equipment, including all electronic equipment necessary to produce, receive, and synchronize the Loran-C signals, and all consumable supplies and spare parts located at the station. An inventory of U.S. owned property and equipment to be transferred is contained in Annex A to this Agreement.

#### **Article II**

All rights for U.S. Government personnel to be present at the station at Ejde shall be waived by January 1, 1995. The United States Coast Guard, on behalf of the United States Government, and the Farvandsvæsenet, on behalf of the Government of the Kingdom of Denmark, shall enter into a separate understanding to delineate the technical arrangements necessary for the implementation of the change of command, control and operation of the station.



### **Article III**

1. The Government of the Kingdom of Denmark shall be held liable for any or all action and claims which may arise as a result of the use and operation of the Loran-C station at Ejde after transfer of ownership from the Government of the United States of America to the Government of the Kingdom of Denmark on January 1, 1995.

2. After January 1, 1995, the Government of the Kingdom of Denmark shall not bring any claims or legal proceedings against the Government of the United States of America, and any agency, instrumentality, contractor, or employee thereof for:

(a) damage to property, both real and personal, including but not limited to economic and/or environmental damage, being transferred to the Government of the Kingdom of Denmark pursuant to this Agreement, or

(b) death or injury to any personnel of the Government of the Kingdom of Denmark or to citizens of Denmark, arising out of the transfer of ownership and the subsequent use and operation of the Loran-C station at Ejde by the Government of the Kingdom of Denmark.

3. All actions or claims which should arise as a result of use and operation of the Loran-C station at Ejde prior to January 1, 1995 shall be governed by Article VIII of the Agreement Between the Parties to the North Atlantic Treaty Regarding the Status of Their Forces, signed at London June 19, 1951, as far as it is applicable.

### **Article IV**

The Contracting Parties shall notify the International Frequency Registration Board (IFRB) of the International Telecommunication Union (ITU) that effective January 1, 1995 the International Frequency List should be modified by the deletion of any reference to the "United States of America" in association with the Loran navigational frequency.

### **Article V**

Either Contracting Party may request consultations if it considers it desirable to amend this Agreement. Any amendment to the Agreement and/or its annex agreed upon as a result of these consultations shall be concluded by the Contracting Parties through an exchange of diplomatic notes.



**Article VI**


Any disputes arising from this Agreement shall be resolved by consultation between the Contracting Parties by diplomatic means and shall not be referred to arbitration, litigation or other resolution.


**Article VII**
