NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966 (80 Stat. 271; 1 U.S.C. 113)—

"...the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence... of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof."

Excellency:

I have the honor to refer to the recent signed Memorandum of Understanding between the United States Department of Defense and the Surinamese Ministry of Defense regarding the planned Special Forces Deployment for Training Exercise Mission SF-6225 which is scheduled to take place in Suriname from 6 February 1996 to 21 March 1996 (hereafter referred to as the "the Exercise").

I have the honor to propose that U.S. Armed Forces personnel and civilian employees of the U.S. Department of Defense ("U.S. personnel") deploy to Suriname to participate in the Exercise and that the Exercise be conducted according to the following arrangements.

The Government of the Republic of Suriname shall accord to U.S. personnel in Suriname in connection with the Exercise status equivalent to that provided to the administrative and technical staff of the United States Embassy in accordance with the Vienna Convention on Diplomatic Relations April 18, 1961.

The Government of the Republic of Suriname shall accord duty-free treatment and exemption from internal taxation upon importation and exportation of products, property, materials or equipment imported into Suriname by or on behalf of U.S. personnel in connection with the Exercise. Prior to the Exercise a list containing the products, property, materials and equipment to be imported duty-free into Suriname in connection with the Exercise will be submitted to the Ministry of Finance, Directorate of Taxes.

U.S. personnel may carry weapons within their area of operations as are necessary to conduct training and for self defense.

U.S. personnel who have been issued drivers licenses by appropriate U.S. licensing authorities may drive in Suriname without Surinamese drivers' permits. The drivers' licenses will be displayed to the Surinamese police authorities upon request.

The Government of the Republic of Suriname and the Government of the United States of America shall waive any and all claims against each other for damage, loss, or destruction of the other's property arising from Exercise activities. Claims by third parties arising out of Exercise activities shall be referred to the government alleged to be responsible for resolution in accordance with the laws of that government.

United States personnel may enter Suriname for purposes of the Exercise with United States military identification cards and collective movement or individual travel orders. Passports and visas shall not be required.

If the foregoing is acceptable to your Excellency's government, I have the further honor to propose that this note together with your Excellency's reply to that effect, shall constitute an agreement between our two governments which shall enter into a force on the date of your Excellency's reply.

I have the honor to acknowledge the receipt of Your Excellency's Note No. 008 dated 17 January 1996, which reads as follows:

"I have the Memorandum of Un honor to refer to the recent signed Understanding between the United Department of Defense and the Surinamese Ministry of Defense regarding the planned Special Forces Deployment for Training Exercise Mission SF-6225 which is scheduled to take place in Suriname from 6 February 1996 to 21 March 1996 (hereafter referred to as the "the Exercise").

I have the honor to propose that U.S. Armed Forces personnel and civilian employees of the U.S. Department of Defense ("U.S. personnel") deploy to Suriname to participate in the Exercise and that the Exercise be conducted according to the following arrangements.

The Government of the Republic of Suriname shall accord to U.S. personnel in Suriname in connection with the Exercise status equivalent to that provided to the administrative and technical staff of the United States Embassy in accordance with the Vienna Convention on Diplomatic Relations April 18, 1961.

The Government of the Republic of Suriname shall accord duty-free treatment and exemption from internal taxation upon importation and exportation of products, property, materials or equipment imported into Suriname by or on behalf of U.S. personnel in connection with the Exercise. Prior to the Exercise a list containing the products, property, materials and equipment to be imported duty-free into Suriname in connection with the Exercise will be submitted to the ministry of Finance, Directorate of Taxes.

U.S. personnel may carry weapons within their area of operations as are necessary to conduct training and for self defense.

U.S. personnel who have been issued drivers licenses by appropriate U.S. licensing authorities may drive in Suriname without Surinamese drivers' permits. The drivers' licenses will be displayed to the Surinamese police authorities upon request.

The Government of the Republic of Suriname and the Government of the United States of America shall waive any and all claims against each other for damage, loss, or destruction of the other's property arising from Exercise activities. Claims by third parties arising out of Exercise activities shall be referred to the government alleged to be responsible for resolution in accordance with the laws of that government.

Unites States personnel may enter Suriname for purposes of the Exercise with United States military identification cards and collective movement or individual travel orders. Passports and visas shall not be required.

If the foregoing is acceptable to Your Excellency's government, I have the further honor to propose that this note together with your Excellency's reply to that effect, shall constitute an agreement between our two governments which shall enter into a force on the date of your Excellency's reply."

I have further the honor to confirm on behalf of the Government of the Republic of Suriname the foregoing arrangements and to agree that Your Excellency's Note and this Note shall be regarded as constituting an agreement between the two Governments, which shall enter into force on the date of this reply.

I avail myself of this opportunity to extend to Your Excellency the assurances of my highest consideration.
