## NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966 (80 Stat. 271; 1 U.S.C. 113)—

"...the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence ... of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof."

## PROTOCOL EXTENDING THE AGREEMENT BETWEEN THE GOVERNMENT OF THE UNITED STATES OF AMERICA AND THE GOVERNMENT OF THE PEOPLE'S REPUBLIC OF CHINA ON COOPERATION IN SCIENCE AND TECHNOLOGY

The Government of the United States of America and the Government of the People's Republic of China (the "Parties"),

Recognizing that the Agreement Between the Government of the United States of America and the Government of the People's Republic of China on Cooperation in Science and Technology signed at Washington on January 31, 1979, as amended and extended (hereinafter referred to as "the Agreement"), will expire on August 27, 2023, and

Acting pursuant to paragraph 1 of Article 11 of the Agreement;

Have agreed as follows:

### Article I

The Agreement shall be extended for six months, effective from August 27, 2023. In doing so, the implementing accord and protocols that are coterminous with the Agreement also shall be extended for six months.

#### Article II

This Protocol shall enter into force on the date of signature of both Parties.

DONE at Beijing, this <u>31</u> day of <u>August</u>, 2023, in duplicate, in the English and Chinese languages, each text being equally authentic.

## 第一条

本议定书自双方签字之日起生效。
