

**Indo-Pacific Economic Framework for Prosperity Agreement Relating to Supply Chain Resilience**

**Done:** San Francisco; November 14, 2023

The Agreement, in accordance with Article 21, paragraph 1 thereof, is open for signature by Australia, Brunei Darussalam, the Republic of Fiji, the Republic of India, the Republic of Indonesia, Japan, the Republic of Korea, Malaysia, New Zealand, the Republic of the Philippines, the Republic of Singapore, the Kingdom of Thailand, the United States of America, and the Socialist Republic of Viet Nam.

**Entry into force:** February 24, 2024

The Agreement shall enter into force 30 days after the date on which at least five of the States listed in Article 21, paragraph 1 of the Agreement have deposited an instrument of ratification, acceptance, or approval with the Depository. For each State listed in paragraph 1 that submits its instrument of ratification, acceptance, or approval with the Depository after the date of the fifth deposit, the Agreement shall enter into force 30 days after the date on which that State deposits its instrument of ratification, acceptance, or approval with the Depository.

In accordance with Article 25, paragraph 1 of the Agreement, any State or separate customs territory may accede to the Agreement, subject to the consent of the Parties and any terms or conditions that may be decided between the Parties and the State or separate customs territory. The Agreement shall enter into force with respect to an acceding Party 30 days after the date of deposit of its instrument of accession with the Depository. Notwithstanding paragraph 1, no State or separate customs territory may accede to the Agreement until one year after the date of entry into force of the Agreement or after the date on which the Agreement has entered into force for all States listed in Article 21, paragraph 1, whichever comes first.
