- Entry into force: [not yet in force] In accordance with Article 3, the Protocol enters into force upon receipt by the Government of the United States of America of notification from all states Parties to the Agreement between the Parties to the North Atlantic Treaty for Co-operation regarding Atomic Information that they are willing to be bound by the terms of the Protocol.
