## NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966 (80 Stat. 271; 1 U.S.C. 113)—

"...the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence ... of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof." The Department of State refers the Embassy of the Islamic Republic of Pakistan to the Agreement on Science and Technology Cooperation between the Government of the United States of America and the Government of the Islamic Republic of Pakistan signed June 25, 2003 (hereinafter referred to as "the 2003 Agreement").

On behalf of the Government of the United States of America, the Department of State proposes to extend the 2003 Agreement for a period of five years until October 23, 2028.

If the Government of the Islamic Republic of Pakistan considers this proposal acceptable, the Department of State further proposes that this note and the Embassy's reply note shall constitute an Agreement between the Government of the United States of America and the Government of the Islamic Republic of Pakistan to extend the 2003 Agreement, which shall enter into force on the date of the Embassy's reply note and shall be effective from October 23, 2023.
